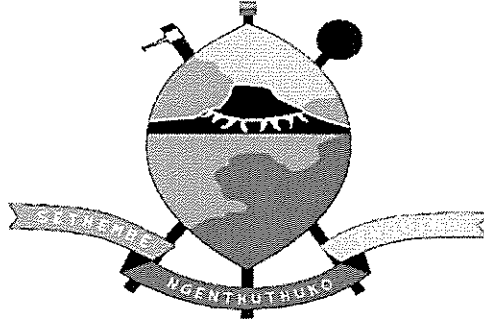

Arial is recommended.• Signboards must withstand outdoor weather conditions (rain, snow, wind, sun exposure) for a minimum of 5 years without significant fading, rusting or degradation.• The materials used must be UV-resistant and resistant to environmental elements such as moisture, temperature fluctuations and chemicals.• Signs should include reflective elements for visibility at night and during low-light conditions. Minimum reflectivity standards must meet local reflective standards.

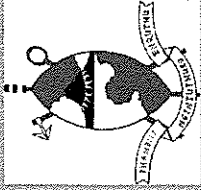

- Illegal Dumping Sites

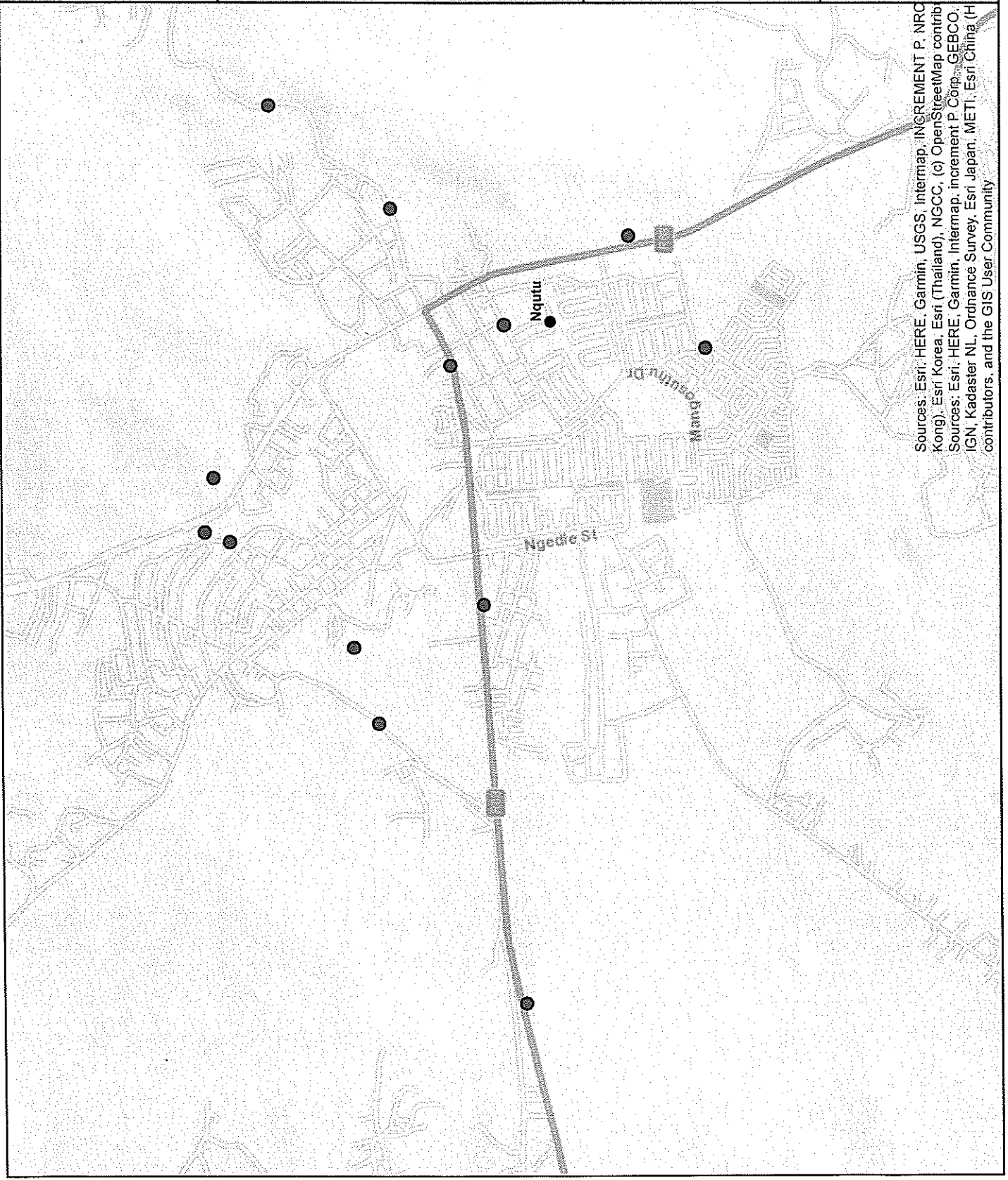
