SITE INSPECTION</b><ul style="list-style-type: none"><li>➤ The bidder must thoroughly inspect all the affected sites within the Municipality and provide a treatment plan.</li></ul></li><li><b>3. REQUIREMENTS</b><ul style="list-style-type: none"><li>➤ The bidder must employ qualified pest control operators.</li><li>➤ The service provider must give at least five years guarantee.</li><li>➤ Holes need to be closed with dowel sticks.</li><li>➤ The site must be left clean.</li></ul></li><li><b>4.
